MISSISSIPPI CORVETTE CLUB, INC. MUST PRE-SELL 300 TAGS BEFORE THE MISSISSIPPI DEPARTMENT OF REVENUE WILL BEGIN PRODUCTION ON THE DISTINCTIVE CORVETTE TAG INCLUDED IN HOUSE BILL 104. WHEN THE DEPARTMENT OF REVENUE RECEIVES 300 APPLICATIONS, WITH THE APPROPRIATE FEES, AND A DESIGN PROVIDED BY THE MISSISSIPPI CORVETTE CLUB, INC. AND APPROVED BY THE DEPARTMENT OF REVENUE, THE TAG WILL BE PUT INTO PRODUCTION. IF 300 TAGS ARE PRE-SOLD BY MAY 15, 2011, THE TAGS WILL BE PRINTED IN JULY. IF 300 TAGS ARE NOT PRE-SOLD UNTIL AFTER MAY 15, 2011 AND BEFORE OCTOBER 15, 2011, THEN THE TAGS WILL NOT BE PRINTED UNTIL JANUARY, 2012.

MISSISSIPPI CORVETTE CLUB, INC. WILL RECEIVE NO FINANCIAL BENEFIT FROM SPONSORING THIS CAR TAG. \$24.00 OF THE SPECIAL TAG FEE WILL BE PAID DIRECTLY TO NATIONAL CORVETTE MUSEUM FOUNDATION, INC. THE REMAINING \$7.00 WILL BE DISTRIBUTED AS PROVIDED BY LAW TO THE COUNTY TAX COLLECTOR, THE MISSISSIPPI BURN CARE FUND, THE STATE HIGHWAY FUND, AND THE DEPARTMENT OF REVENUE. THE ENTIRE \$31.00 WILL BE REFUNDED TO YOU IF MISSISSIPPI CORVETTE CLUB, INC. FAILS TO SELL AT LEAST 300 TAGS WITHIN THE TIME ALLOWED BY LAW.

YOU WILL BE NOTIFIED BY THE MISSISSIPPI CORVETTE CLUB, INC. WHEN YOUR TAG CAN BE PICKED UP AT THE OFFICE OF THE TAX COLLECTOR IN YOUR COUNTY OF RESIDENCE. YOUR TAX COLLECTOR'S OFFICE WILL HAVE A LIST PROVIDED BY THE DEPARTMENT OF REVENUE OF PEOPLE WHO HAVE ALREADY PAID THEIR FEES IN YOUR COUNTY AND ARE ENTITLED TO ONE OF THE FIRST 300 TAGS.

YOU SHOULD PICK UP YOUR TAG AS SOON AS YOU ARE NOTIFIED THAT THE TAG IS AVAILABLE AT YOUR TAX COLLECTOR'S OFFICE. IF YOU CHOOSE TO WAIT TO PICK UP YOUR TAG, THE SPECIAL TAG FEE SHALL BE PAID AGAIN AT THE TIME THE SPECIAL TAG IS PICKED UP TO BE REGISTERED TO YOUR VEHICLE.
